




# How to find my tax documents




### 1099 Form

A 1099 tax form is used to report income received from sources other than an employer.

## Get started

Log in to your account. Select **Accounts** and then select **Statements & Tax Forms**.




## Step 1

During tax season, you'll see the 1099 Dashboard, which offers a personalized view of your tax forms for the current tax year.

Tax forms will appear in the dashboard as they become available; for each form, you'll see a document status of available, pending, or corrected.

**Note:** If your account was converted in 2024 from TD Ameritrade to Schwab, your Consolidated 1099 and 1099-R forms will also be included on the 1099 Dashboard.
